Utah law permits you to make certain decisions regarding Uninsured Motorists Coverage (UM). This document describes this coverage and the options available with respect to Bodily Injury Uninsured Motorists Coverage.

You should read this document carefully and contact us or your agent if you have any questions regarding Uninsured Motorists Coverage and your options with respect to this coverage.

This document includes general descriptions of coverage. However, no coverage is provided by this document. You should read your policy and review your Declarations page(s) and/or Schedule(s) for complete information on the coverages you are provided.

Uninsured Motorists Coverage provides insurance protection to an insured for compensatory damages which the insured is legally entitled to recover from the owner or operator of an uninsured motor vehicle because of bodily injury caused by a motor vehicle accident. This includes damages due to bodily injury resulting from a motor vehicle accident with a hit-and-run vehicle whose owner or operator cannot be identified or from a motor vehicle accident caused by the fault of another party where the other party has no liability insurance.

Utah law generally defines an uninsured motor vehicle to include, in part, a motor vehicle, the operation, maintenance or use of which is not covered under a liability policy at the time of an injury-causing occurrence, or a motor vehicle covered with liability limits lower than required by the financial responsibility law of Utah.

In comparison, Utah law generally defines an underinsured motor vehicle to include, in part, a motor vehicle, the operation, maintenance or use of which is covered under a liability policy at the time of an injury-causing occurrence, but which has insufficient liability coverage to compensate fully the injured party for all special and general damages.

Utah law requires that motor vehicle liability policies include Uninsured Motorists Coverage at limits equal to the lesser of the limits of the Bodily Injury Liability Coverage (split limits) or Combined Single Limit for Liability Coverage in your policy or the maximum Uninsured Motorists Coverage Limits that we have available for your type of policy, unless you reject or select lower limits for Uninsured Motorists Coverage.
